- BRP offers racers, competing on Sea-Doo watercraft, the Sea-Doo Bounty contingency program. This program is designed for the following types of events; closed course watercraft racing. This certificate is not valid for organizations not members of the American Powerboat Association (APBA) or International Jet Sport Boating Association (IJSBA).
- Contingency will be paid for only the listed events sanctioned by IJSBA and/or APBA. All claims must be signed by an event or sanctioning body official, if not, payment will not be made. Racers have the responsibility to have the claim properly completed (providing all requested information) and mailed to the address above. Please allow 5-10 weeks for processing of checks after the June 30, 2009, September 16, 2009, and October 20, 2009 cut-off dates.
- For the 2009 race season, all claims must be sent in by the racer, within 10 days of the event, and postmarked no later than June 30, 2009 (for races taking place between March 15, 2009-June 21, 2009) September 14, 2009 (for races taking place between June 22, 2009 – September 6, 2009) and October 20, 2009 (for the World Finals). Claims postmarked after these dates will not be honored. At some events, there is a possibility that a BRP representative will present publicly an enlarged check only for photography.
- To qualify for the 2009 Sea-Doo X-TEAM Bounty program above noted Sea-Doo watercraft **MUST HAVE Sea-Doo Bounty Logo decals on watercraft**. Sea-Doo logo decals must be a minimum of Two (2") inch tall lettering. **MUST INCLUDE PHOTO OF WATERCRAFT WITH FIRST REDEMPTION.**
- BRP reserves the right to reject a claim not properly or fraudulently filed and reserves the right to cancel this program at any time.
- BRP will NOT accept ANY responsibility for any damages or injuries, including death that may occur during the above described events.
